Pricing Policy

At Little Angels 247 we endeavour to be flexible, however in order to maintain high standards the following pricing policy must be adhered to:

GENERAL ADMISSIONS and FULL YEAR OPTION (full-time place or part-time sessions)

- The setting will confirm a place on receipt of a completed, signed contract.
- Fees are payable in advance, PROMPTLY on the first day of each month.
- A fee of up to £30.00 is payable for returned cheques or fees that are more than 10 days overdue without approval.
- Fees can be paid by cheque, cash, childcare vouchers, standing order or BACS payment.
- Fees are calculated by multiplying the sessions attended by 52 weeks, divided by 12 months, to give a fixed monthly charge.
- A full calendar months' notice is required to reduce sessions or remove a child from Setting; alternatively, one month's fees are required.
- A registration fee of £xx.xx secures a child's place and is not refundable; this includes a Little Angels 247 bag and diary
- Fees are payable for 52 weeks of the year, including bank holidays and adverse weather.
- Any fees outstanding when a child leaves will require payment in full. If this is not forthcoming the payment will be pursued through the county court.
- Fees are payable during periods of absence, including sickness and family holidays.
- There is a £5.00 per day discount for full-time places.
- There is a £10.00 per day discount for the oldest sibling(s) within the same family.
- Fees are reviewed and adjusted as necessary. Parents/carers are informed at least one month in advance of any increase.
- Current fee charges and sessions are available from the Manager.
- No session can be swapped for another, and extra sessions will be charged for.
- Persistent lateness in collecting a child at the end of their session will result in a charge of £2.00 for every 10 minutes or part thereof.
- Upon leaving, any free entitlement paid in advance will need to be paid back in full.
- A child will be eligible for the free entitlement the term following their third birthday. This discount will be applied and fees reduced accordingly. Eligible children attending more than 15 hours for 52 weeks will be entitled to the Teacher Service.

Little Angels 247 **TERM-TIME OPTION** (full time place or part time sessions)

Little Angels 247 operates a 42-week term, with closures of two weeks at Christmas, two weeks at Easter and six weeks in the summer. Exact dates are available on request.

- The setting will confirm a place on receipt of a completed, signed contract.
- Fees are payable in advance, PROMPTLY on the first day of each month.
- A fee of up to £30.00 is payable for returned cheques or fees that are more than 10 days overdue without approval.
- Fees can be paid by cheque, cash, childcare vouchers, standing order or BACS payment.
- Fees are calculated by multiplying the sessions attended by 42 weeks, divided by 11 months, to give a fixed monthly charge (no fees are due in August).
- A full calendar month notice is required to reduce sessions or remove a child from setting;

alternatively, one month's fees are required.

- A registration fee of £xx.xx secures a child's place and is not refundable; this includes a Little Angels 247 bag and diary.
- Fees are payable during periods of absence, including sickness, family holidays and adverse weather.
- Any fees outstanding when a child leaves will require payment in full. If this is not forthcoming the payment will be pursued through the county court.
- There is a £10.00 per discount for the oldest sibling(s) within the same family.
- Fees are reviewed and adjusted as necessary. Parents/carers are informed at least one month in advance of any increase.
- Current fee charges and sessions are available from the Manager.
- No session can be swapped for another and extra sessions will be charged for.
- Persistent lateness in collecting a child at the end of their session will result in a charge of £2.00 for every 10 minutes or part thereof.
- Upon leaving, any free entitlement paid in advance will need to be paid back in full.
- A child will be eligible for the free entitlement the term following their third birthday. This discount will be applied and fees reduced accordingly. Eligible children attending more than 15 hours for the Little Angels 247 term time of 42 weeks will be entitled to the Teacher Service.

FREE ENTITLEMENT ONLY

This is free on the point of entry with hours and sessions agreed with the Setting. It equates to 15 hours free childcare for 38 weeks of the year (three hours per day x five days per week).

Children will have access to the Early Years Foundation Stage.

- The Setting will confirm a place on receipt of a completed, signed contract.
- No session can be swapped for another and extra sessions, if available, will be charged for.
- Persistent lateness in collecting a child at the end of their session will result in a charge of £2.00 for every 10 minutes or part thereof.
- Meals can be purchased from the Setting but are not a condition of entry.
- There is no Teacher Service for the free entitlement only option.

Check with your LA that the times you are offering the free entitlements reflect the requirements regarding flexible parental choice? Also, two year old funding, 30 hours pilot and Early Years Pupil Premium.
